

Terms & Conditions

#CaptureYourFlow Giveaway

1. Contest Period

The #CaptureYourFlow & Win ("Contest") will run from 25th May 2026 to 21st June 2026 ("Contest Period"). All entries received after 11:59pm on 21st June 2026 will be automatically disqualified. Chuan Sin Sdn. Bhd. ("Organiser") reserves the right to shorten or extend the Contest Period without prior notice.

2. Eligibility

This Contest is open to all citizens and permanent residents of Malaysia aged 18 years and above as of 25th May 2026.

3. How to Participate

To qualify for the Contest, participants must complete the following steps:

1. **Capture:** Record a video showcasing your everyday "Flow with Joy" moment, any activity or moment that brings you joy and happiness, and share your story.
2. **Post:** Upload the content to your Instagram feed.
